



ACB court reserved verdict on jail facilities for YSRCP MP Mithun Reddy

The Vijayawada ACB court has concluded hearings on a petition alleging that YSRCP MP Mithun Reddy was provided with special facilities while in jail, and the court has reserved its verdict, which is expected later today. During the hearing, the court questioned officials from the prisons department about the facilities stipulated for an MP. The officials responded affirmatively, acknowledging that the necessary provisions were being made. However, the court emphasised the importance of adhering to standards befitting a lawmaker. The MP, who is currently remanded in custody after being arrested in connection with a liquor scam, has requested numerous amenities through his petition. The court has



directed that he be granted access to a television, a bed, a western commode, three meals a day from outside, a couch, a mosquito net, a yoga mat, walking shoes, newspapers, as well as the ability to conduct private meetings with a supervisor and two lawyers five days a week. Furthermore, he is entitled to regular medication along with notebooks and pens. A decision from the court is anticipated by this evening.



Flood Alert at Prakasam Barrage Due to Heavy Rains

The irrigation authorities have issued a flood alert as heavy rainfall causes water levels to rise at the Prakasam Barrage. The Water Resources Department officials are closely monitoring the situation. Currently, the barrage is experiencing an inflow of 20,748 cusecs, with 18,125 cusecs being released downstream. Additionally, 2,623 cusecs are diverted to the canals. The situation is under continuous review to ensure public safety and effective management of water resources. Further updates will be provided as the situation develops.

PM Modi Reacts to Jagdeep Dhankhar's Resignation, Wishes Him Good Health



Prime Minister Narendra Modi has responded to the resignation of Jagdeep Dhankhar from the post of Vice President of India. PM Modi took to X (formerly Twitter) to laud Dhankhar's service to the country and also wished him good health. "Shri Jagdeep Dhankhar Ji has got many opportunities to serve our country in various capacities, including as the Vice President of India. Wishing him good health," the Prime Minister wrote. PM Modi's praise came after Dhankhar, 74, submitted his resignation citing health reasons. His decision marked the end of his term which began in August 2022.

New Delhi: President Droupadi Murmu accepted the resignation of Jagdeep Dhankhar from the post of Vice President of India on Tuesday. The letter has been forwarded to the Ministry of Home Affairs (MHA), and soon an official notification will be issued. This was announced during the Rajya Sabha proceedings, when BJP MP Ghanshyam Tiwari, who was in the Chair, said that Dhankhar's resignation as the Vice President has been accepted. Tiwari also said that the Ministry of Home Affairs has "conveyed resignation of Vice President of India Jagdeep Dhankhar under Article 67A of the Constitution with immediate effect". Earlier, Prime Minister Narendra Modi extended good wishes to Dhankhar. The PM wrote on X, "Shri Jagdeep Dhankhar Ji has got many opportunities to



serve our country in various capacities, including as the Vice President of India. Wishing him good health." The PM's post came at a time when the opposition has been raising questions about Dhankhar's sudden resignation. Dhankhar, who served as the 14th Vice President of India since August 2022, stepped down on July 21 -- the very first day of the Monsoon Session of Parliament -- citing health concerns. On July 16, 2022, the BJP announced

Dhankhar as the National Democratic Alliance (NDA) candidate for Vice President. In the Vice Presidential election held on August 6, 2022, Dhankhar defeated opposition candidate Margaret Alva with 528 out of 710 valid votes, securing 74.37 per cent -- the highest margin of victory since 1992. As Vice President, Dhankhar also served as the ex-officio Chairman of the Rajya Sabha, where he presided over several key legislative sessions. Known for his strict adherence to parliamentary rules and no-nonsense approach, he was both respected and contested in equal measure across party

lines. Jagdeep Dhankhar, a seasoned politician and constitutional expert, was seen by many as a firm yet fair presiding officer of the Rajya Sabha. He had been hospitalised multiple times over the past year for health concerns, most recently in Nainital. The exact nature of his illness has not been disclosed. In his resignation letter to President Droupadi Murmu, Dhankhar cited health concerns. He invoked Article 67(a) of the Indian Constitution, which provides for the resignation of the Vice President. Jagdeep Dhankhar's resignation has triggered the constitutional process to elect a new Vice President of India, say experts. Since the Vice President also serves as the Chairman of the Rajya Sabha, the post cannot remain vacant for long, according to the experts.

Supreme Court agrees to hear Maha govt's plea against acquittal in 2006 Mumbai train blasts case

New Delhi: The Supreme Court on Tuesday agreed to hear on July 24 the Maharashtra government's plea challenging the Bombay High Court decision to acquit 12 accused in the 2006 Mumbai train blasts case. A bench headed by Chief Justice of India (CJI) B.R. Gavai agreed to urgently list the matter for hearing on Thursday, after Solicitor General (SG) Tushar Mehta mentioned it. Seeking an urgent hearing on the state government's special leave petition (SLP), SG Mehta said that it was a "serious matter" requiring the top court's consideration on "some important issues". In a major ruling delivered on Monday, the Bombay High Court acquitted 12 accused, of whom five were on death sentence and seven others on life imprisonment, in the July 11, 2006, Mumbai blast case. Directing their immediate release from jail, the acquittal order passed by a bench of Justices Anil Kilar and S. Chandak came as a major blow to the investigation agen-



cies. The Justice Kilar-led Bench castigated the shoddy probe prosecution, opining that the prosecution failed to even establish the type of bombs used in the crime. The 12 accused -- incarcerated for 19 years -- succeeded in establishing before the Bombay High Court the fact of torture inflicted on them to extort confessional statements. As a result, it held the statements inadmissible, saying, "On all the tests relating to voluntariness and truthful-

ness of the confessional statements, the prosecution failed." Chief Minister Devendra Fadnavis termed the Bombay High Court verdict as "shocking", saying that the Maharashtra government will move the Supreme Court against it. On July 11, 2006, seven bomb serial blasts in packed Mumbai local trains brought the maximum city to its knees within 11 minutes. The terror attack left 189 dead and over 800 injured. Earlier in 2015, a special court convicted 12 individuals in the case, sentencing five -- Faisal Shaikh, Asif Khan, Kamal Ansari, Ehtesham Siddiqui, and Naveed Khan -- to death, while the remaining seven were given life imprisonment. The prosecution had argued that the attack was planned by Pakistan's intelligence agency, ISI, and carried out by operatives of Pakistan-based militant group Lashkar-e-Taiba with help from the Students' Islamic Movement of India, a banned Indian group.

Telangana should be banned, Adulteration should do justice to the victims

Telangana state convener Dr Diddhi Sudhakar in Hyderabad, Ravindra Bharati, Minister of State for Excise, Tourism & Culture and Archaeological Survivor, Jupalli Krishnarao The petition was handed over. The government should focus on the tragic events caused by adulteration in Telangana. It is heartbreaking to note that more than ten people have lost their lives as a result of a dangerous drink. Adulteration, as a result of thousands of liters of poisonous adulteration market. He recalled that the Congress government had banned sales in twin cities and allowed only sales at swimming and palm trees.

He said that the last KCR government lifted the ban and caused the emergence of liquor mafia to invest in adulterated sale. He demanded that the sale of adulterated Kalu be banned, the incident should be severely punished and the families of the deceased should pay 20 lakhs of ex-gratia. 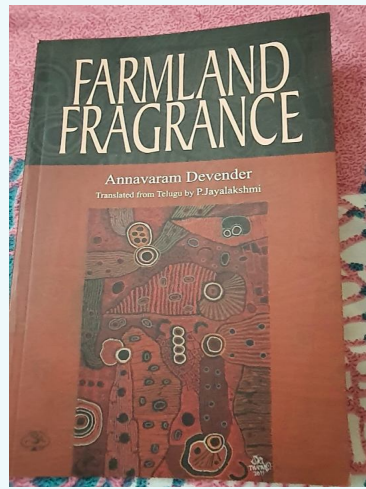
DASHARATHI AWARD 2025 WINNER

ANNAVARAM, POETRY
IS HIS LIFE.

There is revolution and revolutionary Literature in the soil of Telangana. Every town worth its name has produced at least a couple of writers, folk singers, lyricists and martyrs. Many of them are witness to exploitation, penury, pain, plight, longing, loss all such aching elements that have seeped into both the rural and urban life. The poems and stories of Annavaram Devender hold a mirror to such ethos.

Devender is a well known name in the literary circles of both the Telugu States. He has many prize winning anthologies of poetry and stories to his credit that have curved a shining niche for him in the literary edifice of Telangana. According to him, poetry is his second nature and that has on him a therapeutic, soothing influence.

Everyone knows that the oppressive rule of the Nizam from 1946-1951 and the farmers struggle against their landlords for their rights changed the course of Telangana history. When thousands of farmers and the general public lost their lives during these two events, their blood percolated every pore and furrow of this land, giving it an ever lasting, distinctive smell called the scent of the soil. Devender calls it Farmland Fragrance. He picks it up as the title of one of his early anthologies of poetry, consisting 40 odd poems. As a living witness to these historical events, Devender was moved and spurred to write them.



This anthology opens with the poem, SPRING wherein Devender not only sees himself in everything in nature but also declares at the very outset that:

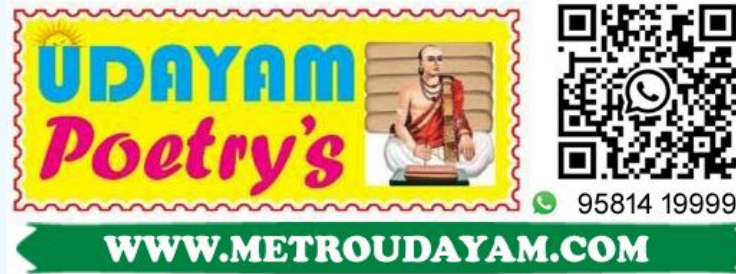
1) Poetry is my heart
my life-giving energy it is.

In another poem, SONG OF THE HEART, the poet sums up in a powerful capsule the cultural ethos of Telangana including its reverberating revolutionary streak:

2) You are the closed fist
the sickle you are
a wave are you
We are warring
for our own dominion.

The double jasmine has multifaceted meanings in different cultural and religious rituals. For the poet, the tree is the birth place for and a silent sentinel to everything Telangana and:

3) a welcome greeting for



Processions
a shade for revolts
.....
an adda to hold a dialogue
a rasta widely known.

The poem, WATER IS, TEARS ALONE, bears the echo of the hopelessness of poet Coleridge who said, water water everywhere/Nor a drop to drink. Here in two small opening lines, Devender brings out the perpetual drought conditions and scarcity of water in Telangana:

4) Drops, in drops alone
water drops dribble

The poem, I M THE MOST EMINENT has a universal appeal as it unfolds the tale of toil and tears of artisans that is almost the same everywhere. Again Revolutionary Literature thrivly throbbed everywhere, touching and transforming the sense and sensibility of Telangana people. There were times when all writers and singers worth their names were intimidated and their works banned. A LETTER is a short poem which screams out the power of the pen of a revolutionary:

5) a letter when imprisoned
will turn into a fiery
clap of thunderbolt

In the year 2011 when this anthology was being prepared, the movement for a separate Telangana State was in full swing. FROM SMALL FISH is the last poem in this collection that conveys the single demand and dream of millions of

people:

6) Three crore voices
stand on one word
one speech
Only Telangana!

The poems in this book are meticulously culled from five other Telugu anthologies of the poet published over a period of many years. This is really a daunting job for Smt P. Jayalakshmi, a retired associate professor of English from Osmania University, who had done the superb job of translating these poems into English with original spirit of theme, tone, and mood intact.

It seems that winning awards has become a habit with Devender as he has bagged 31 awards and titles so far. Yet another feather in his cap is that the Telangana Government yesterday conferred on Annavaram the prestigious Sri Dasharathi Krishna machary Award for 2025 which carries a cash prize of 1,01,116 rupees.

Heavy rain to lash Nilgiris, Coimbatore; Chennai to see dip in temperature

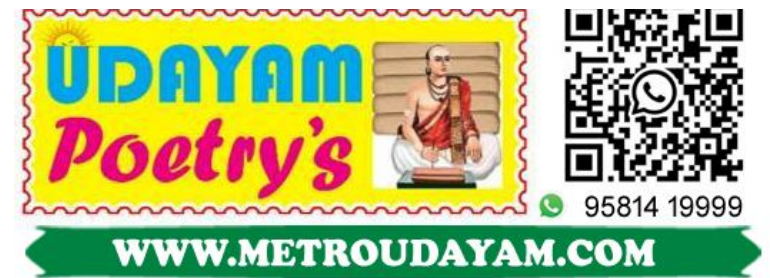
Chennai: Heavy rain is expected to lash the Nilgiris district and the Ghat areas of Coimbatore district, with the Regional Meteorological Centre (RMC) forecasting intense rainfall activity at isolated locations on Tuesday. The warning comes as Tamil Nadu continues to witness a change in weather patterns driven by an upper-air cyclonic circulation over the Bay of Bengal. According to the RMC, the cyclonic circulation lies over south Odisha and extends up to 5.8 km above mean sea level, tilting southeastward with height. This system, which initially stretched from south Odisha to north coastal Andhra Pradesh, is influencing widespread weather activity across Tamil Nadu



and Puducherry. Hyderabad shopping In Chennai, a dip in temperature was recorded after widespread drizzle and overcast skies on Monday. Nungambakkam recorded a maximum temperature of 31.3 degrees Celsius, marking a departure of 4.2 degrees from the normal, while Meenambakkam recorded 31.7 degrees, with a deviation of 3.9

degrees from the usual maximum. The weather department has predicted partly cloudy skies for Chennai on Tuesday, with light showers likely in some parts of the city and suburbs. Thunderstorms and lightning are also expected at a few places across Tamil Nadu and Puducherry, along with wind speeds reaching 40-50 kmph in some areas. The forecast indi-

cates that light to moderate rain is likely at isolated places across Tamil Nadu and Puducherry till July 27. The temperature in Chennai is expected to remain between 32-35 degrees Celsius during the day and around 26-28 degrees Celsius at night for the next five days. Thanjavur recorded the highest maximum temperature in the state at 38 degrees Celsius on Monday, while Karur Paramathi reported the lowest minimum temperature at 21 degrees Celsius among the plains. Meanwhile, Chennai has received 19.8 cm of rainfall from June 1 to July 21 this year -- significantly higher than the normal average of 13.17 cm for the same period, according to RMC data.

सभी धर्म ग्रंथों में धर्मपरायणता से जीवन यापन करने का आदेश मानव को दिया गया है। ईश्वर के आज्ञाकारी बनकर इस दुनिया से चले जाने वाला धन्य है। धर्मपरायणता (जिसे अरबी में तक्वा कहा जाता है) से जीने की बात हमें पवित्र कुरआन में भी देखने को मिलती है। हमारे द्वारा आचरण में लाया जाने वाला कोई भी नेक अमल (अच्छा कर्म) अगर तक्वा (धर्मपरायणता) के साथ आचरण में लाया जाए तो तो ही उसे ईश्वर स्वीकार करेगा। जिन कर्मों में तक्वा न हो उन कर्मों का कोई मूल्य नहीं रहता।

इसलिए आदमी को जो भी कर्म करना हो वह तक्वा के साथ किए जाए तो ही फायदेमंद (लाभदायक) सिद्ध होंगे। तक्वा एक अरबी शब्द है जिसका अर्थ बहुत ही व्यापक है। तक्वा याने ईश्वर-भय याने ईश्वर की अवज्ञा करने से बचने को भी कहा जाता है। और तक्वा पवित्रता को भी कहते हैं। और तक्वा धर्मपरायणता को भी कहा जाता है। तक्वा याने संयम, सचेत रहना, जागरूक रहना भी है। तक्वा परहेजगारी (पापों से अपने आपको बचाने) को भी कहा जाता है।

मुख्तसर (संक्षिप्त) में कहा जाए तो तक्वा याने इशुभीरूता और ईश्वर का सम्मान और ईश्वर के इच्छा के अनुसार अपने जीवन को बिताना होता है। तक्वा यह एक ऐसा गुण है जो आदमी को ईश्वर के निकट ले आता है और आदमी को बुराइयों से बचाता है। और जो बुराइयों से और गुनाहों (पापों) से खुद को बचाता है वही ईश्वर की मारदर्शकता और ईश्वर के कृपा का पात्र बनकर रहेगा।

पवित्र कुरआन के कहने के मुताबिक मार्गदर्शकता का

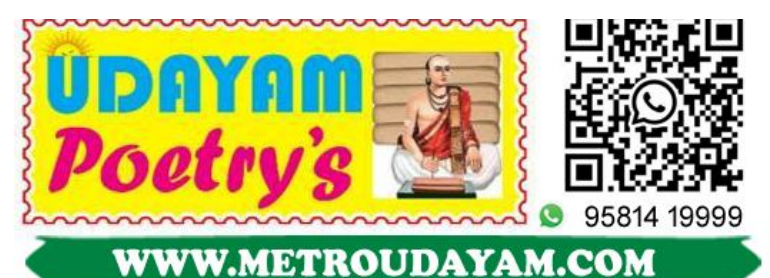

Hyderabad: In a major crack-down in the illegal betting app scam, the Enforcement Directorate (ED) on Monday summoned actors Rana Daggubati, Prakash Raj, Vijay Deverakonda and Manchu Lakshmi for allegedly promoting betting apps across social media platforms. They have been asked to depose on separate dates. Hyderabad real estate Daggubati has been asked to appear before the ED on July 23, followed by Prakash Raj on July 30, Deverakonda (August 6) and Lakshmi (August 13). The ED has booked cases against 29 film and TV personalities under the Prevention of Money Laundering Act (PMLA) and launched an investigation into how huge revenue is gener-



ated through illegal betting and gambling platforms. Official sources said that the celebrities endorsed platforms like Junglee Rummy, JeetWin and Lotus365

in return for promotional fees, without verifying the legal status of those apps. Based on FIRs filed by Telangana and Andhra Pradesh police against them,

the ED launched a probe into the alleged money transactions and hawala transfers from the promoters of the betting apps to the accounts of the celebrities. Police booked cases under relevant sections of Bharatiya Nyaya Sanhita (BNS), the Telangana Gaming Act (2017) – which bans all forms of online betting – and the IT Act. Telangana food Hyderabad food The agency officials will record the statements of the four celebrities during interrogations revolving around possible money laundering. It should be noted that some film personalities have already made statements that they were not aware of the legality of running the betting apps until the police booked cases against them. The ED offi-

cials will analyse the contracts signed by the celebrities during the investigation. The probe will focus on tracing the proceeds of crime and the extent of the money that may have been laundered through promotional deals, sources said. The other celebrities whose names figured in the betting app scam include, Pranitha Subhash, Nidhi Agerwal, Ananya Nagalla, Siri Hanumanth, Sreemukhi, Varshini Sounderajan, Vasanthi Krishnan, Shobha Shetty, Amrutha Chowdhary, Nayani Pavani, Neha Pathan, Pandu Padmavati, Imran Khan, Vishnu Priya, Harsha Sai, Bhairya Sunny Yadav, Shyamala, Tasty Teja, Reethu Chowdhary and Bandaru Seshayani Supreetha.

Nitish Reddy ruled out of England tour



Manchester: India all-rounder Nitish Kumar Reddy has been ruled out of the remainder of the series against England due to a knee injury, while injured pacer Arshdeep Singh will be unavailable for selection for the fourth Test, the BCCI said on Monday. Reddy, who featured in the second and third Tests, picked up the injury while training in the gym on Sunday, with scans revealing ligament damage. "Nitish Kumar Reddy has been ruled out of the remaining two Tests owing to a left knee injury. Nitish will fly back home and the team wishes him a speedy recovery," the BCCI said in a press release. Arshdeep, who is yet to feature in the series, sustained an impact injury to his left thumb while bowling in the nets during a training session in Beckenham last week. "The BCCI Medical Team is monitoring his progress," the statement read. Haryana seamer Anshul Kamboj has been added to the squad as cover, and he has already linked up with the squad in Manchester. The fourth Test is slated to begin at the Old Trafford on Wednesday. Hosts England lead the five-match Anderson Tendulkar Trophy 2-1.
